## AUSTRALIA CHILE FREE TRADE AGREEMENT

The AUSTRALIA CHILE FREE TRADE AGREEMENT (ACLFTA) entered into force on 6 March 2009. From 1 January 2015 all dairy tariffs have been eliminated.
