CHAIRPERSON'S REPORT

The 2018–19 financial year could be considered one of the toughest for a large number of SA dairy farmers, despite improved milk prices in recent months. Pressure on cash flow, availability of feed, high cost of grain and fodder, and in many cases poor on farm seasonal production all contributed to a challenging season.

Moving into next year the increase in milk prices remains positive, coupled with what looks like – on the whole – a reasonable start to the season. While carry over for the early part of the year will still be tough, the longer term outlook of an increase in milk demand is a positive.

DairySA continues to build on their reputation for delivering dairy industry conferences that are relevant and authentic – with a commitment to securing world-class experts on cutting edge research.

Driven by a committee of farmers and other industry members, the events are for farmers, created by farmers, and reflect topics you want to see covered in a meaningful way. With high engagement from farmers, service providers, processors and other industry members we are confident that we are on track with these events.

'On-point' dairy topics, inspirational speakers, and a unique venue were some of the key factors that contributed to the highly successful DairySA Central Conference "Diverse Dairy: Driving Opportunities" held earlier this year. More than 180 dairy farmers, service providers and sponsors gathered at 'The Bend' Motorsport Park at Tailem Bend to hear from US-based calf rearing expert Bob James, along with researchers and experts in the energy, workplace and irrigation space.

DairySA's Innovation Day held in Mount Gambier in June – 'Feedbase for the Future' – had a focus on pasture – how to grow it and how to make the most of it – and saw 195 delegates attend the day, with international speaker Prof Santiago Utsumi on robotics and sensors in pasture management and Dr Rodrigo Albornoz on advances in nutrition for recently calved cows.

If you are keen to be involved in any area of DairySA's activities – including event committees or dairy discussion groups, or if you simply want to chat about how DairySA can assist you or your business – please reach out to any of the DairySA team. WHAT WE DO – A SNAPSHOT

FY 2019 saw DairySA drive over 85 research, development and extension activities engaging over 1575 dairy farmers and industry members. This represents a 12% increase in engagement from 2017–18, with events down by 15.

Over 35 Dairy Discussion Groups were held – engaging over 400 farmers – with groups including Barossa Mid-North, Fleurieu, Lakes, South-East, Meningie, River, Mt Jagged and Focus on Production. The strong membership of the People in Dairy DDG resulted in ten events in the South-East and Central region, with 90 farmer engagements. High numbers were also noted in the Barossa Mid-North group which saw 75 farmer engagements within four events.

Professional development courses driven by the DairySA team included 'Occasional Counsellor' and 'Office Made Ready' workshops, 'Meet the Banker' business preparation, Business Fundamentals and Business Analysis courses. The People in Dairy Discussion Groups continued its strong focus on Farm Safety, and 'Being an Employer of Choice'. In the animal health space workshops included 'Understanding Lameness and Calving', and 'Mastitis and Colostrum Management'. Specialised workshops with international guest presenters were well attended and included 'Understanding Heifer Udder Development' (Prof Russ Hovey, US), 'Managing Heat Stress' (Geoff Dahl, US) and 'Calf Rearing' (Dr Bob James, US). Field Days focussed on Forage, Irrigation and Energy, and Pre-Autumn Seasonal Management. DairySA co-ordinated farmers and farm staff for milk shed tours as part of the Legendairy Royal Adelaide Show Dairy Tours.

As part of our Wellbeing program over 70 women enjoyed a 'Ladies Lunch' late in the year at two separate locations in the Central and South East regions.

Nearly 400 farmers and service providers attended the two DairySA Conferences in 2018–19, including the Central Conference in early March in the Central region and DairySA Innovation Day 2019 in June Mt Gambier.

Note 1 Statement of Significant Accounting Policies

The financial statements are a special purpose financial report prepared for use by members of the Association. The committee have determined that the Association is not a reporting entity and therefore there is no requirement to apply Australian Accounting Standards, Australian Accounting Interpretations and other authoritative pronouncements of the Australian Accounting Standards Board in the preparation and presentation of these financial statements.

The report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report:

(a) Income Tax

No provision for income tax has been raised as the association is exempt from income tax under *Division 50 of the Income Tax Assessment Act 1997*.

(b) Goods and Services Tax

Revenues and expenses are recognised net of the amount of goods and services tax (GST) except where the amount of GST is not recoverable or payable to the Australian Taxation Office.

Receivables and Payables are recognised inclusive of GST.

The net amount of GST recoverable from or payable to the Australian Taxation Office is shown separately in the Balance Sheet.

INDEPENDENT AUDITOR'S REPORT

To the members of Dairy SA Regional Development Program Inc.

Report on the Audit of the Financial Report

Audit Opinion

We have audited the accompanying financial report, being a special purpose financial report, of Dairy SA Regional Development Program Inc. (the Association), which comprises the statement of financial position as at 30 June 2019, statement of comprehensive income, for the year then ended, notes comprising a summary of significant accounting policies and the certification by the members of the Committee on the annual statements presenting fairly the financial position and performance of the Association.

In our opinion, the accompanying financial report of the Association presents fairly, in all material respects, the financial position of the Association as at 30 June 2019, and its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the *Associations Incorporation Act SA 1985*.

Basis for Audit Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the Association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia, and we have fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting and Restriction on Distribution and Use

Without modifying our opinion, we draw attention to Note 1 to the financial statements, which describes the basis of accounting. The financial report is a special purpose financial report that has been prepared to assist the Association to meet the requirements of the *Associations Incorporation Act SA 1985*. As a result, the financial report may not be suitable for another purpose. Our report is intended solely for the Association and should not be distributed to or used by parties other than the Association. Our opinion is not modified in respect of this matter.

Responsibility of Management and the Committee for the Financial Report

Management is responsible for the preparation and fair presentation of the financial report, and has determined that the basis of preparation described in Note 1 is appropriate to meet the requirements of the *Associations Incorporation Act SA 1985* and is appropriate to meet the needs of the members. Management's responsibility also includes such internal control as Management determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

INDEPENDENT AUDITOR'S REPORT CONTINUED

In preparing the financial report, Management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

The Committee is responsible for overseeing the Association's financial reporting process.

Auditor's Responsibility for the Audit of the Financial Report



Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Association to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
