MALAYSIA AUSTRALIA FREE TRADE AGREEMENT

The MALAYSIA AUSTRALIA FREE TRADE AGREEMENT (MAFTA) entered into force on 1st January 2013.
* 35% of annual TRQ administered by an open licensing system, with no restriction on who can apply for a license and no restriction on whether product is imported in bulk or retail packs (0401.10, 0401.20).

ASEAN AUSTRALIA NEW ZEALAND FREE TRADE AGREEMENT

The ASEAN AUSTRALIA NEW ZEALAND FREE TRADE AGREEMENT (AANZFTA) entered into force on 1st January 2010.

WORLD TRADE ORGANIZATION

Under the terms of its WORLD TRADE ORGANIZATION (WTO) commitment, Malaysia is required to offer at least 1 million litres of milk quotas with an in quota tariff rate of 20%. The Government of Malaysia can increase this allowable limit depending on market situation. The out of quota rate is 50%.

In recent years the total WTO liquid milk + cream TRQ has exceeded 5 million litres.

1,825,089 litres in total divided as follows: Peninsular: 1,105,089, Sabah: 300,000, Sarawak: 420,000.

5,063,148 litres in total divided as follows: Peninsular: 3,827,441, Sabah: 500,000, Sarawak: 735,707.

2,123,461 litres in total divided as follows: Peninsular: 1,113,461, Sabah: 1,010,000.
